Whereas on April 9, 2018 Council considered Report DS-18-67 from the Commissioner of the Development Services Department and approved the Development Services Committee's recommendation in the report which included, in part, the following:

"That, pursuant to Report DS-18-67 dated March 22, 2018, the Region of Durham Health Department be requested to initiate a public consultation process, with input from the City, Durham Regional Police, Durham Region Emergency Medical Services, Lakeridge Health and other community organizations to discuss the Region-wide opioid response, including education, types of Supervised Injection Site services, including Overdose Prevention Sites, and possible locations."; and,

Whereas Lakeridge Health Oshawa, the Durham Region Health Department and the John Howard Society of Durham Region have advised they are proposing to submit a proposal to the Provincial and Federal Governments for a Consumption Treatment and Services (C.T.S.) site in Oshawa prior to the end of March 2019; and,

Whereas Health Canada requires a proponent of a C.T.S. to submit a community consultation report as part of the application package; and,

Whereas as of February 20, 2019 the City has not yet been advised of the location of the proposed C.T.S. site and is not aware of any public consultation being completed for the proposed site as requested in the City's April 9, 2018 resolution as outlined above; and,

Whereas the City recognizes the health care crisis related to the use of opioids and is aware of the benefits of C.T.S.'s; and,

Whereas however in the absence of a comprehensive public consultation process on a proposed site it is difficult to support any proposal being submitted to the Province and Federal Government at this time; and,

Whereas only after considering public input on a proposed site can the City make an informed decision on a proposal;

Therefore, be it resolved:

- 1. That the City cannot commit to supporting a proposed Consumption Treatment and Services site in Oshawa until the public consultation process requested in the April 9, 2018 Council resolution is undertaken and the City is apprised of the public input related to a proposed C.T.S. site.
- 2. That the Federal Government and Province not approve a C.T.S. site in Oshawa at this time until a comprehensive public consultation process is undertaken with input from the City.
- 3. That a copy of this resolution be sent to Lakeridge Health Oshawa, the Durham Region Health Department, the John Howard Society of Durham Region, the Province of Ontario and the Federal Government." Carried as amended by later votes
