#### CS-19-19 Reconstruction of Simcoe Street and Winchester Road

Whereas this is a high traffic volume intersection in close proximity to the Hwy 407 East entrance and exit ramps;

Therefore the City of Oshawa forthwith request the Region of Durham include an uninterruptable power supply in the traffic signals so they remain operational during power outages." Carried
