Whereas the traffic studies would need to be completed by the Region of Durham; and,

Whereas if requested by the Region of Durham, Development Services staff will assist the Region in the event they wish to engage the commercial plaza property owner at 562-564 King Street East and Tim Hortons to review any queuing challenges related to vehicles backing up on Wilson Road North.

Therefore, be it resolved, that the Region of Durham be requested to investigate the traffic concerns on Wilson Road North between King Street East and Bond Street East.
