Recommendation

1. That, as there is a potential surplus of funds available (subject to financial completion of approved projects) from 2019 and years prior of \$96,000, the surplus funds be allocated to:
 - Continue to explore the design options for an accessible elevator at Fire Hall #1 (\$40,000); and,

- Advance a design of Animal Services accessible renovations (\$16,000); and,
 - Implement the Airport Terminal elevator upgrades to comply with current accessibility standards (\$40,000); and,
2. That the proposed 2020 Accessible Capital Projects (\$150,000 subject to Council's funding approval) include the following:
- Installation of a universal washroom at Thornton/Dundee Community Centre (\$50,000); and,
 - Accessibility improvements to the main entrance and the installation of a universal washroom at Animal Services (Farewell) (\$75,000); and,
 - Explore design options for the improvement of accessibility at the North Oshawa Community Centre (\$15,000); and,
 - Contribution to the Radio Park accessible pathway and site furnishings (\$10,000).
